## **Mystic Aquarium in the News**



Mystic Aquarium's Arctic Coast, the **largest outdoor beluga whale habitat in the United States** (at 750,000-gallons) made quite a splash in June 2021.

In addition to its existing three belugas (Juno, Natasha & Kela), the Sea Research Foundation imported belugas from Canada.

The belugas, viewable to the public, are participating in non-invasive beluga research. These findings are essential to the advancement of knowledge and conservation, which will impact our

current beluga pod as well as their counterparts in the wild.

# **Development Overview**

Mystic Aquarium relies on <u>philanthropic support</u> and volunteer engagement to support its mission of inspiring people to care for and protect our ocean environment through conservation, education, and research.

The Aquarium has a \$22 million annual revenue budget. The Development Department, led by **Senior Vice President of Development Tina Couch**, raises \$2 million annually from individuals, corporations, and foundations for critical needs not covered by ticket sales and membership. The Department is developing plans to significantly increase this annual philanthropic total.

The Board of Directors and the Development Committee are strong partners in the identification, cultivation, and solicitation of donors.

The Aquarium is in the early stages of a comprehensive capital planning process to determine the organization's next set of critical priorities, the steps needed to achieve them, and the long-term growth of philanthropy at the



Aguarium. The position described in this Prospectus will be integral to the success of those plans.

## **Institutional Giving Officer - The Opportunity**

Mystic Aquarium is seeking an **Institutional Giving Officer** to help build a robust pipeline of growing support from corporations, foundations, and governmental funders. This key position will be responsible for identification, cultivation, solicitation, and stewardship of institutional funders.

Reporting to the Senior Vice President of Development, the **Institutional Giving Officer** will build relationships with prospects and funders, collaborate with members of the Development team and other Aquarium staff to optimize gift support, and serve as a passionate and persuasive ambassador for the Aquarium's ambitious plans.

#### Responsibilities

• Lead and manage research and proposal writing for all institutional prospects; this includes coordinating and monitoring the tasks of the various participants.

- Proactively identify, research, and evaluate corporate, foundation, and institutional giving opportunities. Prioritize institutional giving opportunities for senior administration based on advancement's strategic plans.
- Oversee the development of case statements, letters of inquiry, proposals, reports, and other correspondence to corporations, foundations, and government agencies, and other institutional giving organizations.
- Serve as a resource to researchers and provide guidance and support to investigators in the identification and development of federal and state institutional giving opportunities.
- Work with Aquarium staff to develop programmatic aspects of institutional giving proposals; develop project budgets in accordance with appropriate funding regulations and college policies; provide technical assistance; ensure that all proposals are reviewed by area managers prior to submission. Oversee development proposal content, design, and creation.
- Other duties as assigned.

#### **Qualifications and Skills**

The ideal candidate will have a keen understanding of the institutional funding landscape and have experience soliciting institutional funding from corporations, foundations, and government agencies. This person will be strategic, detail oriented, a skilled writer, and an excellent collaborator.

- Bachelor's degree.
- Proven experience in preparing institutional proposals and securing significant philanthropic awards in the non-profit, higher education, or government sectors.
- Ability to write clearly and persuasively to translate the Aquarium's mission and aspirations into successful proposals and presentations.
- Strong oral and written communication with all stakeholders including funding agencies, administrators, and Aquarium staff.
- Ability to collect, synthesize, and analyze data about the institution and its impact.
- Ability to create and manage project and program budgets, and fund accounting.
- Ability to work in a diverse environment with the ability to multi-task and be the project manager on several institutional giving simultaneously.
